**1. Securing the booking of the event:** To secure a date, a signed contract is required with a 20% deposit due at the time of signing. The deposit is non-refundable and non-transferable. Please be advised that dates and scheduled makeup times will only be reserved when a signed contract and deposit are received. Arranging a trial does not reserve the makeup artist's services for the event.

**2. Payment:** Payments can be made in cash or online payment via [vanessacocomakeup.com](http://vanessacocomakeup.com)

If the non-refundable deposit of 20% is made in cash it will be due on the day of the trial.

If the client decides to pay the non-refundable deposit of 20% via [vanessacocomakeup.com](http://vanessacocomakeup.com) then he/she will have one week from the day of the trial to make the payment and secure the date. Failure to pay the non-refundable 20% within the stated time will result in the date being canceled.

The final balance is due on the day of the event as one payment - no exceptions. The person responsible for the entire balance of payment is the person who has signed the booking contract.

**3. Satisfaction Guaranteed:** Makeup will be completed to client's satisfaction, but is not to exceed allotted makeup time. Ample time is given for each makeup upon booking. Acceptance of completed makeup application by client is acknowledgement by client that makeup is done to his / her satisfaction.

**4. Responsibility of the client:** The client shall inform the makeup artist of any issues that may affect the use of any equipment or products. This includes but is not limited to sensitivities, allergies and medical conditions. The makeup artist cannot be held liable for any losses that are incurred due to the client's failure to inform them of any known condition.

The makeup artist reserves the right to refuse service to the client or members the party for, but not limited to, abusive and threatening behavior

**5. Cancellation:** All deposits paid by client will be refunded if contract is cancelled within four (5) days of contract signing. After the five days grace period, should a client cancel the booked event or any service on a contract, the deposit will not be refunded or transferred. In the event that the contracted Makeup Artist is unable to perform the services agreed by circumstances beyond his/her control the client will receive a full refund.

**6. Service location and requirements:** Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements the makeup artist needs to complete the makeups. A "set up" table/work area needs to be made available for the makeup artist at said location. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly.

**7. Travel expenses:** The client will cover any necessary travel expenses of the makeup artist as agreed at time of booking this is to include should it be required congestion charging and parking charges.

**8. Use of image:** The client agrees that the makeup artist may use any photography for publicity purposes which include but are not limited to the makeup artists website and social media pages.
